Sansone Group/CORFAC International Wins Four National Awards *Scott Savacool Earns CORFAC's Top Individual Honor for Third Consecutive Year*

St. Louis, MO -- (March 15, 2010) -- **CORFAC International** today announced that **Sansone Group/CORFAC International** won four national awards in different categories for network transactions among CORFAC professionals in 2009. Each year CORFAC recognizes brokerage professionals and firms for completed commercial real estate sales or leases in which two or more professionals from different firms represent a company and close a joint assignment.

At CORFAC's annual winter conference two weeks ago in Phoenix, Arizona, St. Louis-based Sansone Group/CORFAC International walked away with Most Referred Joint Assignments by an Individual, Most Referred Joint Assignments by a Company, Top Retail Deal by Value and Top Retail Lease by Size.

U.S.-based CORFAC International has 50 firms in the U.S., Canada and Mexico in 64 locations. In association with King Sturge, BDI, Rios Commercial and Latin American Corporate Property Services, CORFAC covers 150 markets worldwide with over 3,000 real estate professionals.

Scott Savacool, Sales & Leasing Associate, won the national award for Most Referred Joint Assignments among all U.S.-based commercial real estate brokers affiliated with CORFAC International in 2009. Mr. Savacool participated in 38 closed, joint transactions with other CORFAC professionals. It was the third consecutive year in which Mr. Savacool participated in more joint transactions than all other CORFAC International brokers.

Sansone Group also won the award for Top Referring Firm, having referred 46 joint transactions to other CORFAC firms throughout North America.

Sansone Group was also involved in the top two retail transactions closed by a CORFAC affiliate firm in 2009. Mr. Savacool co-brokered the Top Retail Deal measured by Value, in referring Scottrade Inc. to Brett Zelner, Senior Managing Director, and Mike Antkies, Executive Vice President, of New York-based Lansco Corp./CORFAC International. The Lansco brokers negotiated a 2,600 square foot lease for Scottrade on Broad Street in New York City and the transaction was valued at more than \$2 million.

Tim Cherre, Vice President of Leasing for Sansone Group, won the Top Retail Lease by Size in referring La Frontera Village L.P. to Dan Gostylo, a Principal of Providence Commercial Real Estate Services/CORFAC International, based in San Antonio, Texas. Mr. Gostylo negotiated a 4,000-square-foot lease for La Frontera on 116 Sundance Parkway in Austin, Texas.

“In one of the toughest real estate climates in recent history, Sansone Group’s 2009 production was definitely a highlight within the industry and certainly for CORFAC International,” said Owen Rouse Jr., CORFAC International 2010 President.
